

Valmet Investor Insights - IR Newsletter Q1/2022



The first quarter of 2022 is behind us, and it is time to wrap up the quarter before the publication of Valmet's Interim Review January–March 2022 on April 27. Please note that the silent period will begin on April 6.

Recent events

Forward together - Neles is now part of Valmet! On March 21, 2022, Valmet announced that Valmet and Neles have received all competition approvals for the merger of Neles into Valmet. On April 1, 2022, Valmet announced that the statutory merger of Neles Corporation into Valmet has been registered with the Finnish Trade Register and as a result of the registration of the completion of the Merger, Neles has been dissolved. Neles is consolidated to Valmet as of April 1, 2022, and it forms Valmet's fifth business line called Flow Control.

Valmet's **Annual General Meeting 2022** was held in Helsinki on March 22. The Annual General Meeting decided to pay dividends of EUR 1.20 per share for the financial period ended on December 31, 2021. The dividend was paid on March 31, 2022. The Annual General Meeting confirmed the number of Board members as eight, however, before the completion of the merger of Valmet and Neles (the "Effective Date"), the number of members of the Board of Directors was six. Aaro Cantell, Pekka Kemppainen, Per Lindberg, Monika Maurer, Mikael Mäkinen and Eriikka Söderström were re-elected as Board members. Jaakko Eskola and Anu Hämäläinen were elected as new Board members for the term commencing on the Effective Date. Mikael Mäkinen was re-elected as the Chairman of the Board and Aaro Cantell was re-elected as the Vice-Chairman of the Board until the Effective Date, from which date on Jaakko Eskola acts as the Vice-Chairman of the Board.
